ADMISSION TO B.Sc. NURSING COURSE ON N.R.I. CATEGORY SEATS (Academic Year 2023-24)

Prospectus & Instructions to the Applicants

- 1. Applications for admission to first year B.Sc. Nursing (Academic year 2023-24) in the 12 (Twelve) NRI category seats at Holy Family College of Nursing is being invited on the basis of this prospectus.
- 2. Eligibility: To be eligible to apply for the B.Sc. Nursing course, the applicant must have completed and passed the 10 + 2 examination with 80% marks under the Kerala State Higher Secondary Board (Kerala HSC) or Central Board of Secondary Education (CBSE) or Indian School Certificate Examination (ICSE) after a period of 12 years study, the last two years of study comprising of physics, Chemistry and Biology with English at a level not less than the core course for English as prescribed by the National Council for Educational Research and Training (NCERT).

Note: All applicants must have taken courses in Biology, Physics and Chemistry in addition to English in the High School Years (during their 10th, 11th and 12th). They should have secured at least 80 % marks in Biology, Physics, Chemistry & English at the Plus Two level (2nd year) and the aggregate percentage of these subjects are considered for the preparation of rank list.

Wherever alphabetical grades like A, B-, C+, etc. are used by the school, appropriate equivalence in terms of percentage like 90%, 75% and 60% should be made available.

Only students from higher secondary schools accredited by the respective State or the country and as such approved by the Association of Indian Universities and Kerala University of Health Sciences will be eligible for admission and **Equivalency Certificate** to this effect shall be produced.

- 3. **Age Requirements:** Applicants must be at least 17 years of age on 31st December 2023 (the date of birth being shown on the Matriculation or equivalent certificate).
- 4. Eligibility for admission to N.R.I. Category Seats: According to the GO(MS) No.243/2014/H&FWD dated 06.08.2014, "An Applicant who depends upon his/her Father / Mother / Brothers and Sisters (inclusive of first cousins) / Husband / Wife / Brothers and Sisters (inclusive of first cousins) of Father or Mother / Half Brother / Half Sister / Adopted

Father or Adopted Mother who is working abroad" will only be eligible to apply in the NRI category seats.

The NRI relative who is sponsoring the candidate should be an Indian Citizen/Overseas citizen of India/Person of Indian Origin and relevant document to prove the same.

- 5. Copy of the following documents to prove the NRI status of the sponsor shall be submitted:
 - Passport copy and Visa / Green card/OCI documents of the sponsor attested by Embassy. The job of the sponsor should be mentioned in any of the above documents; OR if self-employed, a statement in this regard that is duly attested by the Embassy.
 - ii. In case the employment of the sponsor is not mentioned in the above documents, the candidate has to produce the employment certificate of the sponsor attested by the Embassy consulate authorities.
 - iii. Candidate shall produce the sworn affidavit from the sponsor in a stamp paper worth Rs 200. The same shall also be notarized by the Notary Public, disclosing that student is the dependent of the sponsor and the all expenses i.e tution fees and special fee of the candidate for the entire course period will be borne by the sponsor (Model-Annexure 1)
 - iv. Relationship Certificate to be issued by the Revenue Authorities to prove the relationship between the candidate & the NRI relative as per GO(MS) No.243/2014/H&FWD dated 06.08.2014.

6. **FEE STRUCTURE:** A selected applicants in NRI category is liable to pay the following fees:

Note: Apart from the schedule of fees given above, the students will be required to pay the proportionate administration/affiliation/examination fee, etc. payable to the University from time to time. Hostel & Mess fee will be charged separately.

7. Scheme of Admission:

- i. Application Form will be available in www.hfconsg.com from 12/06/2023 and need to be completed online
- ii. The printout of application form should be submitted with self-attested copies of necessary certificates and an application fee of Rs.2,000/- (Rupees Two Thousand only) as DD in favour of Holy Family College of Nursing, Thodupuzha
- iii. The print out of applications along with copies of relevant documents should reach Holy Family College of Nursing, Thodupuzha East PO, Idukki District Kerala before **4:00 pm**, on **02-08-2023**. The applicants can submit their application directly or through speed post. *The college cannot be held responsible for non-receipt or late receipt of applications*, *under any circumstances*. The application form should be completed carefully; furnishing the entire information called for. Late and incomplete applications and applications not in the prescribed format will be rejected. Provisional rank list will be published on **17/08/2023**.
- iv. Self-attested Photocopies of the following documents shall be attached with the Application (The originals documents will have to be submitted at the time of admission).
 - a) School Leaving Certificate (S.S.L.C.) of student establishing that the student has completed 17 years of age as on 31-12-2021.
 - b) HSCE or equivalent examination mark-sheet / pass certificate.

- c) Proof for NRI status (as mentioned in 5)
- d) A statement to show that the high school in which the student has studied has been accredited by the State/Country/University (if applicable).
- e) Equivalence Certificate from Association of Indian Universities (if applicable).
- f) Eligibility certificate from Kerala University of Health Sciences (if studied outside Kerala).
- 8. As per the regulations of the University and the Regulatory Council, admissions will have to be closed in this year. After closure of admissions, the seat, if vacated, cannot be filled up. Such seats will go vacant for the entire duration of the course. Therefore, those who leave the course after the closure of admissions will have to pay liquidated damages equivalent to the tuition fees for the remaining period of the course. Any complaints in this regard shall be subject to the legal and factual scrutiny and the decision of the ASC/FRC. The colleges shall return the Certificate and TC of these students, on execution of a bond by the student along with any of his/her Parents, undertaking to pay the amount that may be ordered by the ASC/FRC or the Court of Law.
- 9. All students who get selected should get themselves vaccinated against Hepatitis (if possible Covid also) before admission. A certificate to the effect shall be produced at the time of admission or before commencement of the course.
- 10. Every student is required to adhere strictly to the Code of Conduct of the college.
- 11. **Ragging is strictly prohibited.** If it is found during the admission or any time there after that the applicant has indulged in ragging in the past, admission may be refused or the student shall be expelled from the institution. Whoever commits, participate in, abets or propagate ragging within or outside the institution shall be suspended from the institution with immediate effect and the Principal shall report the matter to the civil/police authorities.
- 12. Without prejudice to the directions of the Nursing Councils/Government/University, the decision of the Holy Family College of Nursing shall be final on all matters with regard to admission.
